### New Numbers: Howard County 2017 Overdoses Continue To Rise

Howard County Police report overdoses so far in calendar year 2017: 56\* Fatal and 169 Non-Fatal

In fatal cases, some deaths are pending autopsy results for opioids and/or other substances. Numbers may fluctuate.

### Maryland's Opioid Intervention Swap And Share Held in Howard County

Earlier this month, Maryland's Opioid Operational Command Center (OOCC) hosted an Opioid Intervention Team (OIT) Promising Practices Swap and Share at the Howard County Public Safety Training Center. The event provided an important platform for OIT teams from counties across the State to share best practices and lessons learned to fight against the opioid crisis.

# Warning to All Parents: Mother May Have Died From Overdose After Touching Son's Drug Paraphernalia

HC DrugFree continues to warn parents, grandparents, educators, and others not to touch, sniff or taste what they suspect could be drugs. These drugs not only can kill your children/students, but they CAN KILL YOU.

Recently, a mother may have died from cleaning up drug paraphernalia after her own 45 year old son's drug overdose. The mother is thought to have done what most mothers would do out of love, grief, and necessity – clean up the mess left after their child's overdose.

Pending autopsy, the suspicion is that the drugs may have been absorbed through her skin. Both mother and son died.

Talk to the EMS team and police officers if you have an overdose at your house to properly remove of any drugs or paraphernalia. Use extreme caution!

### Baltimore County Police Officers Became III After Exposure To Fentanyl

On December 22, three Baltimore County police officers became ill after exposure to the deadly drug called fentanyl. Simply by packaging evidence and exposure to the white powder, the officers experienced flu-like symptoms associated with fentanyl exposure and were treated.

Exposure to fentanyl is extremely dangerous for all first responders (as well as unsuspecting family and friends).

### **Increase In Fentanyl Feeds Opioid Crisis**

Skyrocketing fentanyl seizures illustrate its growing contribution to the opioid crisis.

U.S. border patrol agents seized only about 2 lbs. of fentanyl in 2013 and nearly 1,500 lbs. this past year. Fentanyl is more than 50 times more powerful than heroin and can be deadly. **Yes, fentanyl is a drug used in Howard County.** 

Often, individuals start down the path to illegal drug use after being prescribed legal pain medication (opioids) for an injury or after surgery. Protect yourself and your family. Ask the right questions and KNOW the facts before taking an opioid.
